REQUEST FOR INFORMATION

A. Introduction

1. The NATO Communications and Information Agency (NCIA) is conducting market research to identify potential sources and gather information regarding industry capabilities to support NATO's Alliance Persistent Surveillance from Space (APSS) Programme. This Request for Information (RFI) is issued solely for informational purposes and does not constitute a Request for Proposal (RFP), Request for Quotation (RFQ), or invitation for bid.

B. Purpose

1. The purpose of this RFI is to obtain input from industry to help inform the NCIA's acquisition planning. Responses to this RFI will assist in refining requirements, identifying capabilities, and shaping the strategy for any future solicitation.

C. Background

- 1. The mission of NATO's Alliance Persistent Surveillance from Space (APSS) Programme is to enhance Alliance situational awareness and decision making through the establishment of a virtual constellation and the integration of timely, persistent and relevant data and services from Space. The Alliance must keep pace with the rapid developments taking place in the commercial space sector in terms of growth in capability and participants. There is an increasing level of capability in industry terms of new and diverse space sensor data and ability to deliver insights based on multiple diverse fused data sets. Therefore, a service or platform to rapidly request, compete and procure data and services from space related to surveillance is anticipated.
- 2. This project seeks to deliver a market survey on existing web based rapid procurement competition, award and delivery platforms which facilitate the secure exchange, sharing, and monetization of space-related data across a broad spectrum requirements for NATO APSS and NATO Space Situational Awareness (SSA). The NCIA is exploring the operational and technical implications of a service/platform, which would support NATO space procurements for APSS and SSA. This market survey will form the basis to further inform this decision-making.

Annex B – Draft Requirements / Statement of Work (SOW/PWS)

Note: This is a DRAFT and subject to change. The NCIA is seeking industry feedback.

1. Background

The NATO Communications and Information Agency (NCIA) requires existing web based rapid procurement competition, award and delivery platforms which facilitate the secure exchange, sharing, and monetization of space-related data across a broad spectrum requirements for NATO APSS and NATO Space Situational Awareness (SSA). The NCIA is exploring the operational and technical implications of a service/platform, which would support NATO space procurements for APSS and SSA. This market survey will form the basis to further inform this decision making.

2. Scope

The Contractor shall provide a web based platform that provides a **Marketplace** including, but not limited to:

- **a.** Centralizes Point of Access to space industry (vendor) data and service providers: Platform that serves as a single point of access for space situational awareness and space based surveillance data and services companies.
- **b.** Provides a secure data exchange: Includes robust cybersecurity protocols and identity management to ensure data integrity, confidentiality, and controlled access based on user roles and permissions
- **c.** Enables fast bid and award cycles: Allows for rapid "short duration" competitive contract awards that facilitate multiple providers to compete to respond to specific task requests, with a quick turnaround delivery. Allows short duration, task or mission specific contracts with the time from tender to award under 24 hours.
- d. Performs performance tracking and feedback: Vendors engaged through task or delivery orders are typically evaluated using contractor performance after award including rapid debriefs and "discussions to capture best practices and areas for improvement. Performance along the lines of
- **e.** Data quality metrics (latency, accuracy, coverage)
- **f.** Usage-based assessments—e.g., how frequently or reliably a vendor's dataset is used by system integrators or end users.
- **g.** Operational feedback from operators who receive service—used to gauge whether data met expectations, timeliness, and reliability.
- h. Vets Company capabilities and compliance: ensure all participating companies in the marketplace meet NATO security, compliance standards, meet operational capability standards, and support mission success. Ensure that capabilities are more than "PowerPoint deep"
- **i.** Enables Immediate Operationalisation: The web-based platform is day zero ready with existing contracts with vendors. What is the readiness of the platform?

3. Objectives

1. This is an opportunity for the NCIA to better understand the current industry capabilities to provide a web-based tool to meet these requirements. The answers to the following questions will be treated in confidence and kept internally for NATO use only. It is not the Agency's objective to force service providers into last-minute additions to their service baseline.

2. Any web based marketplace tool capable of satisfying the above requirements in Annex B should be able to operate on an unclassified system (i.e. the NATO cloud environment). If selected for demonstration, the tool should also be ready to use now and not be a capability under development.
